WELCOME A letter from Andy Knott, CEO



2019 was cracking. It delivered us shooting bans on several very wellknown estates, a landmark Conservative Party manifesto pledge to not repeal the Hunting Act 2004 - the reverse of previous years - and the first guilty plea in over 370 cases prosecuted under it.

We brought together the best charities in the sector to bring forward the longawaited Animal (Sentencing) Bill, soon to be passed. Supporters rallied around, one even running a desert marathon to raise funds for us, and many more including some of the country's most loved figures lent us their names in our relentless drive to stop cruel 'sports'.

It was a year in which we saw our regional supporter groups grow and flourish, our sanctuaries improved, our reach extended, and new hearts and minds won over. There was barely a week, and sometimes a day, where the work we do alerting the public to the extent of animal cruelty wasn't front and centre in the national press. We are now entering a new decade. Together, let's determine to make it the best ever for animals. Let's stop the hunting, the shooting, the animal fighting, together with other cruelty associated with them. Let's give animals a voice. Let's bring change.

UNITEDAGAINST HUNTING

The announcement of a general election in November 2019 heralded not only the opportunity for the human voices of Britain to be heard, but the voices of animals too. Read on to find out more about the impact of our election campaign.



As we have demonstrated in the past, general elections provide the perfect platform for us to shape the debate, challenge what is acceptable and seek support to end hunting with dogs from the general public and politicians alike.

We are the leading charity that stands up and says "no" to the persecution of animals in the name of 'sport'. We have proved our credibility time after time to parliament and the press, and we headed once more into the fray to focus on one single, powerful objective; ensuring a parliamentary majority of anti-hunt MPs.

We mobilised supporters to contact their candidates and drive a commitment to securing, and strengthening, the Hunting Act 2004. We launched an Election Roadshow and toured the country with Vinny, our fox campaign figure-head, spreading our election objectives.

We drove our message out to the press, over social media, and via our impressive celebrity supporters Bill Oddie, Chris Packham, Ricky Gervais, Megan McCubbin, Maxine Peake, Gemma Collins, Gemma Atkinson and Lucy Watson.

We campaigned around the clock to ensure the greatest impact for animals in the short six week lead up to polling day. And we were only able to do this thanks to the commitment, engagement and dedication of you, our supporters.

And on 13th December, the results were in and WE DID IT. Another anti-hunting parliament has been returned to Westminster and for the first time since the Hunting Act passed in 2004, the Conservative Party dropped its pledge to repeal the ban.

Does this mean hunting has stopped? Sadly, no. However, it is important to acknowledge the power we have to influence public policy, and bring us one step closer to ending hunting for good.

Our focus now will be to ensure the Conservative Party stands by the animal welfare and animal sentencing promises it made in its manifesto, including ensuring the Hunting Act 2004 is not overturned. More than that, we'll be insisting the party scrutinises the act with a view to strengthening it, to finally put a stop to hunting for 'sport'. This campaign has shown the power of the League and supporters when we stand together. Once again we made hunting a key issue.

This is the power of what we can do together. We will continue to campaign to strengthen the ban, and lobby land owners, such as the National Trust, to deny hunts access to their land.

Together we are United Against Hunting.

THE ROAD TO ENDING HUNTING

The general election is over, but what does the result mean for animals hunted for 'sport'?



Myth: The general election result has no positive outcome for animal welfare

Busted: For the first time since 2004, the 2019 election saw the threat of the repeal, or weakening, of the Hunting Act withdrawn. We must be vigilant, and we need to focus on the strengthening of the Act, but for the first time in sixteen years, we do not have to fight against the possibility of its abolition. This is a positive result.



Myth: Hunting won't stop until the Hunting Act 2004 is strengthened

Busted: It is true that the chasing and killing of animals is still taking place on a mass scale. However, this could be stopped if landowners prevented the hunts from gaining access to their property. Our campaign focus for 2020 is to deny hunts access to public and private land including the National Trust, one of the country's largest landowners, local authorities and private landowners.

No land means no hunting. While strengthening of the Hunting Act 2004 is essential, in the mean time we can minimise the cruelty inflicted to animals in the name of 'sport'.



Myth: Hunters go unpunished

Busted: Fox hunting takes place over 10,000 times a year and while it would be impossible to prosecute every one, illegal hunters are held to account when sufficient evidence is found. In the recent example of the Meynell and Staffordshire Hunt trial (see page 15 for further details), huntsmen were held accountable for their illegal actions. We believe it was a pitiful punishment, but remains as proof that the Hunting Act 2004 can result in successful prosecutions when properly enforced.

YORKSHIRE WATER CAMPAIGN WIN

Our biggest campaign win of 2019 paves the way for grouse shooting to end on Yorkshire Water land.

Yorkshire Water is one of the largest landowners leasing moorland for grouse shooting. Eleven moors across the county were leased out, with permits issued allowing shooting parties to meet on water catchment areas to kill 'game' birds for entertainment.

Wild animals including foxes, stoats, weasels and hare were being killed by trap, snare and guns on the company's land to ensure large numbers of 'game' birds were available for shooting. Our aim is to end shooting, and thanks to our 18-month high-profile campaign alongside Ban Bloodsports on Yorkshire's Moors (BBYM), we are proud to announce the beginning of the end for grouse shooting.

Rather than automatically renewing shooting licences – as had been the case – Yorkshire Water has committed to stringently reviewing every lease as it runs out. Based on the grounds the company has set out, it is our view that no more leases will be renewed.



This is a landmark decision and paves the way for grouse shooting to end on Yorkshire Water land, which prior to our campaign was not an option.

Thousands of you made your voice heard by taking action with us. You contacted Yorkshire Water to urge them to ban shooting on its land, you visited our campaigning booths around Yorkshire, you joined our rally in Bradford, tuned into our Lush podcast, handed out campaign postcards and shared our messages on social media. Thank you.

There is still plenty of work to do, but let's take pride in the fact that the shooting industry's days are numbered.

We commend Yorkshire Water for taking this big step and listening to its customers and those that care about animals and the environment. Our next steps will involve working with them to ensure their land is no longer used for blood 'sports'.



WE MAKE A GREAT TEAM.

Together, we have significantly improved the horizon for birds on Yorkshire Water land. Our expertise, coupled with your donations and dedication, is a force to be reckoned with. We really couldn't do our work without you and we hope you are as proud of this achievement for grouse as we are.



Thanks to your actions, the University of Reading has taken the decision to ban shooting on its land. Current licences are up for renewal in February and are being terminated as you read this.

As well as supporting our direct action outside the university gates during the popular twoday Freshers' Fayre, more than 8,000 of you wrote to the Vice Chancellor calling on the university to commit to scrapping 'game' bird shooting rights.

Following a full consultation that included both the League and the pheasant shoot, as well as other stakeholders, this is exactly what has happened.

This is just another nail in the shooting industry's coffin. Following on from our campaigns, again supported by you, both the University of Wales and Natural Resources Wales have decided they will ban shooting on their land.

We will continue to urge all private landowners to follow these good examples and ban shooting for 'sport' on their land.

Together, we can end commercial shooting in the UK.





CELEBRATING SUCCESS.

UNVERSITY OF READING ENDS PHEASANT SHOOTING ON IS LAND

One more win for us, one giant leap for persecuted pheasants.



DAILY QUEST FOR LIFE

While the country has been in a political fervour, for the animals who roam free on our wildlife sanctuaries, it has been business as usual. Our Head of Conservation & Education, Paul Tillsley, reports on the state of the sanctuaries over the autumn period.

Unconcerned by human political machinations, the animals that live on the League's wildlife sanctuaries continue their daily quest for life.

The annual red deer rut on Baronsdown has died down and stags that had been arch-rivals just a few months ago are now friends again. Several different stags came and went throughout the rut and took their place as master over a harem of hinds, only to be usurped a few days later by another stag. This was an unusual rut and it could be that a reduction in the total number of mature stags in the area and changes in the climate are both having an effect.



League supporters were able to get a grandstand view of the action during the 'rutting weekend' in mid-October when the rut was at its peak.

Hazel dormice have again done well in the League's sanctuaries, bucking the national trend. We monitor the populations of these endearing mammals at Baronsdown, Cowley Wood and Cove Down and this year there were dormice breeding on all three sites. Our Cove Down wilding project also featured in the December issue of Birdwatching magazine.

We have had a large influx of birds arriving from continental Europe this autumn, with big flocks of chaffinch, wood pigeon, redwing and starlings appearing on the sanctuaries, together with the mysterious woodcock, whose appearance tends to coincide with the November full moon.

There has been a bonanza of berries, seeds, fruit and nuts for birds and mammals alike to fill up their reserves on and help them through the long winter ahead.



We had an early taste of winter in the middle of November, when a few inches of snow fell over a period of five hours bringing down some trees and snapping the tops off others.

Hunting and shooting continue apace around all the League's sanctuaries and the disturbance and death that goes with these cruel pastimes makes the sanctuaries even more vital as refuges for wild animals. A few of the hunts have tested the boundaries of the League's land and 'sporting' rights this season and they have been rewarded with advisory letters from our solicitor. The League will take further action if the hunts persist.

JUSTICE FOR MAN'S BEST FRIEND

As a direct result of our two-year investigation, which uncovered an international network of dog fighters, UK dog fighter Liam Patterson has been banned from keeping dogs for fifteen years. Patterson is also subject to a community payback order, which means he will remain under supervision for two years, placed under a home curfew, and will be required to fulfil 300 hours of unpaid work.

How it unfolded

Our investigation led us to an Eastern European network of cruelty who bred, transported and helped organise dog fights here in the UK. Sharing our findings with the BBC, the network was exposed on the BBC TV News and BBC Radio 4 PM programme.

Upon further investigation, we discovered that Patterson, who lives in Dumfries Scotland, was connected to this group and we identified indicators including weighted collars, training equipment, such as a treadmill and jaw strengthening apparatus, as well as online profiles that outlined his dogs' fighting bloodlines.

Presenting our intelligence to the Scottish Society for the Prevention of Cruelty to Animals (SSPCA), together we achieved a search warrant for Patterson's home address. Working with SSPCA, we provided analytical support that ensured Patterson was convicted. Our investigation has also identified further possible law breakers and we will continue to lead the charge to end dog fighting.



UNITED, WE ARE STRONGER.

We do not receive government funding, so it is only thanks to generous people like you that we are able to investigate dog fighters like Patterson. On behalf of man's best friend, thank you.

HUNTS ON TRIAL

On 2nd October 2018, in Spath Covert near Sutton on the Hill in Derbyshire, a heinous act of animal cruelty was committed. Two members of the Meynell and South Staffordshire Hunt were hunting fox cubs, an act for which they pleaded guilty at Nottingham Magistrates Court in November 2019.

The trial followed an investigation by Derbyshire Police, which was based on video evidence obtained by our very own team of professional investigators.

Sam Staniland, former huntsman of the Meynell and South Staffordshire Hunt, and William Tatler, joint master of the hunt, were each fined £350 and ordered to pay £150 costs.

This is a pitiful fine. We are calling for political parties to commit to strengthening the law on hunting and people who illegally hunt foxes to be given prison sentences.



END HUNTING

Martin Sims, our Director of Investigations, told the press:

"We welcome this conviction for fox cub hunting, a callous crime which the vast majority of the public will regard with horror. To receive just a fine for this barbaric activity shows the need to strengthen the Hunting Act 2004, including the introduction of prison sentences. This is the second time members of the Meynell and South Staffordshire Hunt have been convicted of hunting fox cubs in the same patch of woodland, which indicates the hunt are showing a blatant disregard for the law."

14 years after hunting with dogs was banned in England and Wales with the introduction of the Hunting Act 2004, this case is a stark reminder as to why the ban needs to be strengthened to include custodial sentences, as well as closing the loopholes that enable more hunts to avoid being prosecuted for killing wild animals for 'sport'.

LEAGUE IN ACTION

PROVIDING INSPIRATION OVERSEAS

French charity One Voice invited our Head of Campaigns, Nick Weston, to travel to Paris and address an audience of approximately 1,000 antihunt supporters. England and Wales were the first countries to ban hunting with dogs and the opportunity to inspire another nation was truly enriching.

It was an impressive event that saw more than 1,000 people march through the French capital to the sound of a brass band and chants of "enough bloodshed, enough animals killed" and "stop hunting/hunting kills!" At the end of the march, Nick addressed the crowd in French (despite not speaking a word) and we wish the campaign every success.





INTERNATIONAL ANTI -BULLFIGHTING NETWORK

Public opinion is now firmly opposed to what is perhaps the most famous of spectator cruel 'sports'. Bull fighting continues in nine countries; although the movement to ban it is very strong in all of them.

Nick Weston once again took to Paris to represent the League at the International Anti-bullfighting Network. While our work is UK-based, we continue to highlight the cruelty of bullfighting and are involved in attempting to ban the bloodsport for good.

Having a presence in this network provides the League with a key insight into what is going on in the campaign to end bullfighting, as well as being able to offer support to other organisations.

LEAGUE IN ACTION

INTELLIGENCE TEAM WINS 'BIGGEST INFLUENCER' AWARD

Thanks to our Animal Crimewatch confidential reporting service, funded by our supporters, we collect multiple reports of animal cruelty in the name of 'sport' every day. Intelligence-led investigations are the ones that stand the best chance of success and we were proud to have the efficiencies we have achieved recognised by the company that provides our intelligence software, CLUE. The 'Biggest Influencer' award is a huge testament to the team and how they tackle animal cruelty and wildlife crime.





LEAGUE'S COMMUNICATIONS TEAM FINALISTS FOR CHARTERED INSTITUTE OF PUBLIC RELATIONS (CIPR) AWARD

At the end of 2019, we were shortlisted in the Not For Profit category of the Chartered Institute of Public Relations' PRide Awards (Southern England and Channel Islands). We entered our Boxing Day campaign from 2018, which saw us significantly change the national narrative from being all about the traditional imagery of red coats on horseback to being one about Labour's new commitment to animal welfare, influenced by the League, and polling showing public support for keeping the ban in place.
